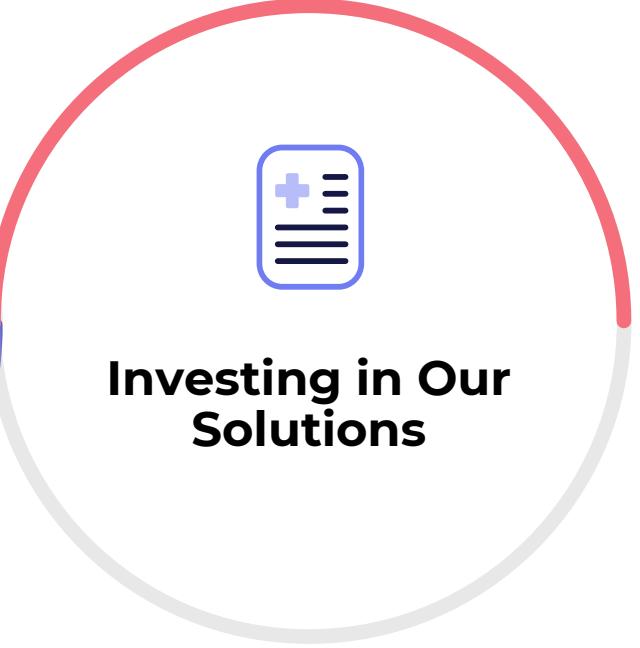

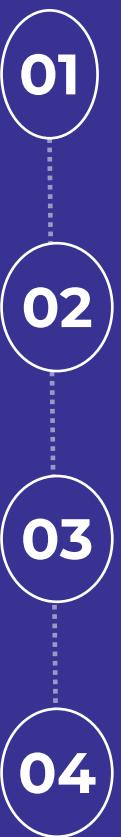

2024 Regulatory Reminders



Reporting on eCQMS ONLY

- ✓ Must have upgraded to TouchWorks Version 22.1.7 or higher and you must have also installed FHIR R4 Version 22.2 or higher by Dec 31, 2024.

Call Outs!

- *To be compliant, both versions are required.*
- *Your FHIR R4 endpoints must be up, not blocked, and publicly accessible.*



New! 2024 Attestation Requirement

High Priority Practices SAFER GUIDE

- ✓ Must attest “Yes” to having completed the High Priority Practice requirements by Dec 31, 2024.

Recommendation

This is attestation is now an annual requirement; establish a process to complete the guide and save your documents.



HTI-1 Mandate FHIR R4 Endpoint Requirements

Client's Responsibilities

- ✓ Must log into the License Management Portal (LMP)
 - review and update your organization's information by Dec 20, 2024

Note: Step-by-step instructions provided to each client, if assistance is needed, contact your Client Success Executive!

- ✓ Establish process to monitor your FHIR R4 endpoints; must be up, not blocked, and publicly accessible.

Promoting Interoperability Performers

To ensure compliance, **by July 4, 2025, you have upgraded to** TouchWorks version 2024.3 or later and **installed** FHIR R4 version 24.5 or higher.

FHIR R4 endpoints must be up, not blocked, and publicly accessible.
