Regulatory Landscape Update

HTI-4 Final Rule (Effective July 31, 2025)

- **What it means:** New requirements for electronic prescribing, prescription benefits, and prior authorization.

THREE KEY CHANGES:

1. **Electronic prescribing standard update**
 - **New Requirement:** NCPDP SCRIPT standard version 2023011
 - **Deadline:** Jan 1, 2028 (aligns with Medicare Part D)
 - **Impact:** All electronic prescribing must use updated standard
2. **Real-time prescription benefits**



- **New requirement:** enhanced real-time prescription benefits
 - **Deadlines:**
 - ASTP/ONC criteria: on Jan 1, 2028.
 - CMS Part D: Jan 1, 2027.
 - **Impact:** New criteria required for Base EHR certification
- 3. Electronic prior authorization**
- **New requirement:** adopts new API standards based on FHIR and HL7 Da Vinci project.
 - **Deadline:** pending
 - **Impact:** new criteria for both Health IT and Payers

2026 Quality Payment Program Proposed Rule Updates

- **What's new:** Reviewed key highlights from the 2026 Quality Payment Program proposed rule for MIPS, MIPS Value Pathways and the new Ambulatory Specialty Model (ASM).

System Updates and Compliance

TouchWorks CEHRT Compliance – ACTION Required

- **CRITICAL:** TouchWorks requires a hotfix for 2025 compliance due to a CCDA narrative text issue via API generation.
- **What you need to do:**
 1. **Submit a Support Case** to request your hotfix.
 2. **Verify your production environment** is upgraded to the correct version.
 3. **Complete hotfix upgrade** by the last day of your 2025 Promoting Interoperability performance period.

CHPL Certification Simplification

- **Good news:** Finding your EHR Certification number just got easier!
- **What changed:**
 - **Old way:** Multiple dot versions to choose from
 - **New way:** Single primary version option covers all dot versions.
 - **Where to find it:** TouchWorks 2025 is now available on the [CHPL website](#)
 - **Impact:** We will continue to communicate what the minimum CEHRT version is each year, but clients will only need to select the primary version to place in their “cart” to obtain their EHR Certification ID number.

FHIR R4 Endpoint Monitoring

- **HHS Enforcement Alert**
- **Breaking:** [HHS announces crackdown on health data blocking](#) the U.S. Department of Health and Human Services (HHS) announced that Secretary Robert F. Kennedy, Jr. has directed HHS to increase resources dedicated to curbing the harmful practice of information blocking. HHS will take an active enforcement stance against health care entities that restrict patients’ engagement in their care by blocking the access, exchange, and use of electronic health information.
- **What this means for you:**
 - FHIR R4 “patient” endpoints must be **always accessible**
 - Active monitoring is **not optional**
 - Quick issue resolution **is critical**
- **Action steps:**
 - Implement and maintain monitoring process for your endpoints
 - Fix issues immediately when detected
 - Submit a Support case if you need assistance
 - *Remember: We are in this together!*

- **CDS/Subscription Manager**
 - **Access:** Use TouchWorks “CDS Console” single sign-on
 - **Important:** Stop using Veradigm Subscription Manager
- **FHIR and License Management Portal**
 - **Access:** [Altera LMP](#)
 - **Important:** Thank you to all clients for your assistance and coordination with our efforts!

- **Unity and ACDM (Direct Messaging)**
 - **What to expect:** Proactive Support cases coming
 - **Your part:** Respond quickly to coordinate with technicians
 - **Timing:** Testing during business hours, production updates after hours

- **Required System Version:** TouchWorks v2025.3.1 + FHIR Supplemental Update
- **What's included:**
 - USCDI v3 support
 - Social Determinants of Health (SDOH) capabilities
 - Insight Measures support

Promoting Interoperability	First day of 180-day reporting period OR July 5, 2026	Whichever comes first
eQMs Only	Last day of performance period OR Dec 31, 2026	More flexibility
ACO/Medicare Shared Savings	Verify with ACO Administrators	Requirements may vary

- **ACTION:** Contact your Client Success Executive (CSE) now to schedule your upgrade!

Special Updates

- **Electronic Case Reporting (eCR)**
 - **Status update:** CDC paused EHR vendor beta testing and general onboarding in June but plans to restart soon with new process.
 - **2025 impact:** CMS proposed to suppress the Electronic Case Reporting measure for 2025 performance year.
 - **Important:** You still must submit a data submission response (No/Yes/Exclusion) to receive your Promoting Interoperability score.
- **Windows End of Life - Oct. 14, 2025**
 - **HIPAA Reminder:** using outdated or unsupported systems may violate compliance requirements.
 - **Action:** Ensure your organization is prepared!

Quality Reporting (QRDA) Export

- **Two Export Types Available:**
 - **QRDA 1** – Patient-level Data
 - Contains patient PHI
 - Very large zip files
 - Use for: Data registries, third-part data transfers
 - **QRDA 3** – Summary Data
 - No Patient PHI
 - Smaller files
 - Use for: MIPS/MVP and other Medicare incentive program data submissions

Access: Available through VCRS Reporting Dashboards for independent export
