Finalized Encryb™ deprecation for note edits: Finalized documents that had contained Encryb forms **only allow editing of the finalized output text.** The Encryb "container" is gone.



HCC updates to support **version 28 coding**, with a **"Current"** (for v24) or **"New"** (for v28) tooltip for the HCC icon and **RAF Scores** for both v24 and v28 calculations.



Fix for bolded text retained from Text Templates in Unstructured note for notes saved moving forward.



FollowMyHealth® communication documents fix so that new FollowMyHealth communication documents **are no longer created blank.**

Altera is focused **on planning the next release of TouchWorks EHR: 2024.1** and meeting regulatory requirements. The final rule for the 21st Century Cures Act, which came out on Dec. 13, 2023, will determine much of the release scope and timeline.
